

COOKIES POLICY

In this Cookies Policy you will find information on the use that **PRODUCTOS QUÍMICOS GONMISOL, S.A.U.** (hereinafter, "SUANNUTRA"), with registered address at Passeig de la Verneda, 47, 08930 Sant Adrià de Besòs, Barcelona, makes of the cookies and similar technologies that are installed on the User's devices and terminals when visiting <https://gonmisol.suannutra.com/> (hereinafter, the "Website").

1. Acceptance of the Cookies Policy

The User accepts the use of cookies and similar technologies and this cookie policy by ticking the corresponding box. In the event that the User accepts the use of cookies and the present cookie policy, the warning of the first layer of information will no longer be displayed during the corresponding session. Likewise, the User may modify the configuration of cookies through the tool provided for this purpose.

2. What are cookies

Cookies are small files that contain certain information about the User's navigation through the website. Cookies are sent to the User's browser and stored on the User's computer.

3. Types of cookies

- Depending on the entity that manages the domain from which the cookies are sent and processes the data obtained, two types of cookies can be distinguished:

Own cookies: those that are sent to the user's terminal equipment from a computer or domain managed by SUANNUTRA from which the service requested by the user is provided.

Third-party cookies: those that are sent to the User's terminal equipment from a computer or domain that is not managed by SUANNUTRA, but by another entity that processes the data obtained through the cookies.

In the event that the cookies are installed from a computer or domain managed by SUANNUTRA but the information collected through them is managed by a third party, they cannot be considered as own cookies.

- There is also a second classification according to the length of time they remain stored in the User's browser, which may be:

Session cookies: designed to collect and store data while the user accesses a website. They are usually used to store information that only needs to be kept for the provision of the service requested by the user on a single occasion.

Persistent cookies: the data remains stored in the terminal and can be accessed and processed for a period defined by the party responsible for the cookie, which can range from a few minutes to several years.

- Finally, there is another classification with five types of cookies according to the purpose for which the data obtained are processed:

Technical cookies: those that allow the user to navigate through a website, platform or application and the use of the different options or services that exist therein, such as, for example, controlling traffic and data communication, identifying the session, accessing restricted access parts, remembering the elements that make up an order, carrying out the purchase process of an order, making the application for registration or participation in an event, using security elements during navigation, storing content for the dissemination of videos or sound or sharing content through social networks.

Personalisation cookies: these allow the User to access the service with some general characteristics predefined according to a series of criteria in the User's terminal, such as the language, the type of browser used to access the service, the regional configuration from which the service is accessed, etc.

Analysis cookies: these allow the party responsible for them to monitor and analyse the behaviour of the Users of the websites to which they are linked. The information collected through this type of cookies is used to measure the activity of the websites, application or platform and for the elaboration of browsing profiles of the Users of these sites, applications and platforms, in order to introduce improvements based on the analysis of the data on the use made by the Users of the service.

Advertising cookies: allow the management, in the most efficient way possible, of advertising spaces.

Behavioural advertising cookies: these store information on the behaviour of Users obtained through the continuous observation of their browsing habits, which allows a specific profile to be developed in order to display advertising based on the same.

Cookies from external social networks: these are used so that visitors can interact with the content of different social platforms (facebook, youtube, twitter, linkedIn, etc..) and are generated only for Users of these social networks. The conditions of use of these cookies and the information collected are regulated by the privacy policy of the corresponding social platform.

4. Purpose of cookies

Cookies are used to capture information about the User's browsing in order to, by analysing it, find out how the User interacts with the website, and thus optimise the browsing experience.
